# REGULATORY CONSIDERATIONS OF CAMPGROUNDS ON FARMS

Farmers or landowners who want up to 3 campers on their field for personal use are fine when they RENT; however, farm campgrounds should follow all the health and safety codes private campgrounds do. Questions to be considered:

# APPROVED SEPTIC / WASTE REMOVAL & OTHER CONCERNS:

- Where are the farm campgrounds dumping human waste/wastewater or garbage
- How will the toilet facilities be controlled?
- How will the campsites be monitored to avoid barns and animals or other sources of odors and flies?

#### APPROVED WATER SOURCE:

- What is the freshwater supply in farm campgrounds?
- · How is the water being sampled by the DNR as required for private campgrounds?

# **EMERGENCY RESPONSE & SAFETY:**

- How will roads be designated and laid out for disaster purposes for ambulances, police, and fire trucks?
  And will they be graded for those vehicles?
- How fire codes be met with only 10' min distances between campsites?
- · What would prevent campers from locating in a flood zone?

# RECORD KEEPING / LICENSING & INSPECTION:

- Who will determine if there are violations for health/safety how and when will they be addressed?
- How will the Health department trace infectious diseases?
- Will reservations or other records be kept? How will law enforcement know if a person of interest is staying there?
- How will structures be treated? What fire codes will they meet? Are monoxide detectors and fire equipment required in any rentals?
- How will you control non-RVIA stickered units? Without this control, homemade vehicles not inspected for safety would be allowed onsite.

# **USE & DESIGNATION OF SITES / LENGTH OF STAY:**

- · What gates are controlled on the property?
- How will you stop more than six people at a campsite can you have 30 people in one unit?
- · What distance will be required between the roads and the campsites?
