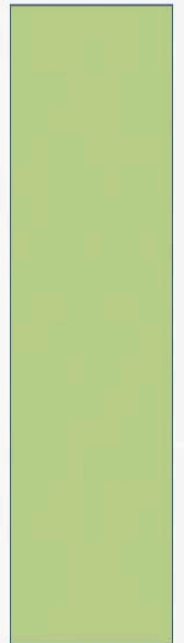




EYE ON LOBBYING: How to Pay Fees

WISCONSIN ETHICS COMMISSION



FEES (PER LEGISLATIVE SESSION)

- Single Lobbyist License - \$250
- Multiple Lobbyist License - \$400
- Authorization to Lobby - \$125
- Principal Registration - \$375
- Limited Principal Registration - \$20
- FOCUS Subscription - \$100

PAYING LOBBYING FEES

- You must login to the website to pay fees
- You must have permission from a principal or lobbyist to pay fees

Pay Fees

Users have two options for payment of fees:

- Pay Online with E-Pay, the State's electronic payment system: transfers money directly from a User's bank checking or savings account, or
- Print Invoice and Pay with Cash or Check: download an invoice and return the form along with a check made payable to "Wisconsin Government Accountability Board".
- If you are a Veteran qualified to receive a free license, download an invoice and return the form along with your certification number that you have received from the Department of Veterans Affairs.
