3 From the Milwaukee County Board of Supervisor's Legislative Liaison, Office of
4 Government Affairs, requesting authorization to communicate Milwaukee County's (the
5 County) position on provisions contained in the Governor's proposed 2017-2019
6 Biennial Budget that impact the County, recommending adoption of the following:

8 **AN AMENDED RESOLUTION**
9

10 WHEREAS, on February 8, 2017, the Governor presented his proposed 2017-
11 2019 State of Wisconsin Biennial Budget (State Biennial Budget) to a joint session of
12 the Legislature; and
13

14 WHEREAS, included in the proposed 2017-2019 State Biennial Budget are
15 provisions that would impact Milwaukee County (the County) in various ways; and
16

17 WHEREAS, the Milwaukee County Board of Supervisor's (County Board)
18 Legislative Liaison, Office of Government Affairs, prepared a written report on
19 February 11, 2017, (File No. 17-282) which details each provision in the proposed State
20 Biennial Budget that would affect the County in the following areas: Health and Human
21 Services, Juvenile Justice, Transportation and Public Works, Judicial and Public Safety,
22 and Local Finance; and

24 WHEREAS, the Wisconsin Counties Association has also prepared a written
25 report of recommendations and positions on the provisions included in the proposed
26 2017-2019 State Biennial Budget; and

28 WHEREAS, while several provisions in the proposed State Biennial Budget align
29 with the County's mission to provide the greatest amount of service and resources to its
30 residents, there are also a number of key items that would negatively impact the
31 communities and programs specifically in the County; and
32

33 WHEREAS, the County Board's Legislative Liaison, Office of Government
34 Affairs, has met with policymakers and departmental staff to determine which of these
35 provisions serve, hinder, or require further scrutiny in pursuit of the best interests of the
36 County; and

38 WHEREAS, it is critical that the County communicate its position on these
39 individual State budget provisions in the areas of Health and Human Services, Juvenile
40 Justice, Transportation and Public Works, Judicial and Public Safety, and Local Finance
41 to provide policy direction for the County's lobbying efforts during deliberations on the
42 2017-2019 State Biennial Budget; and

44 WHEREAS, the Committee on Intergovernmental Relations, at its meeting of
45 March 21, 2017, recommended adoption of File No. 17-278 as amended (vote 4-0);
